The hockey season is fast approaching and once again Robert Bateman High School will be hosting the **28th Annual “Bur-Bear” Winter Carnival Hockey Tournament**. This year’s tournament will be held February 2-3-4, 2012 in conjunction with the City of Burlington’s Winter Carnival.

It is hoped 32 teams will be confirmed and assigned to two pools of 16 teams. **Confirmations will be emailed on receipt of the entry form and required fees.** Spots will only be held for teams who have made the initial deposit of **\$300.00**. There will be no refund for teams that remove themselves from the tournament after December 1, 2011. It is very important that coaches make sure that they have approval for the tournament by their administration prior to submitting entry. If you need a request with regards to start time, please indicate that on the entry sheet, no promises but we will do the best to accommodate.

A final coach’s package will be mailed to you by the first week of January, 2012.

- Round Robin within each Division (3 games guaranteed)
- 1st place teams in their respective Divisions (A or B) advance to Gold semi-finals and finals
- 2nd place teams in their respective Divisions (A or B) advance to Purple semi-finals and finals
- Game Length 2 x 12’s, 1 x 15 stop time periods (round robin games and semi’s), 3 x 15 for finals
